Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that a fire incident occurred on Wednesday, June 4, 2025, at around 10:01 PM at the Company's factory located at Artemis Complex, Gala No. 105 & 108, National Express Highway, Vasai (East), Thane – 401208, Maharashtra, India. We are pleased to inform that there were no casualties or injuries to any personnel during the said incident. The Company's team is closely working and cooperating with the local and state authorities to restore normalcy at the affected site. The Company is assessing the extent of damage caused and is cooperating with the concerned authorities for further investigation and necessary actions. In view of the incident, operations at the said factory shall remain suspended for a period of seven days. The statutory compliances for the said incident will be followed as per the applicable law. The cause of fire is being investigated and the Company is committed to extend all assistance to the relevant authorities investigating into this matter.
